The Western monitor that was to be located at Mentone Park Primary School will now be located to a more Northern Point due to the suggested location not being suitable. Airservices will test the Western location with a hand monitor for a short term and will report on the results.

Monitors are ready to be installed by early October and the first reporting should be available for March 2015 CACG.
